There is a certain Declaration of Condominium, the Central Square Villas Office Condominium (the Declaration) was recorded October 7, 2009, in the Eric County Clerk's Office in Liber 11170 of Deeds at Page 8656; and amended; and

WHEREAS, the By-Laws of the Condominium were attached to the Declaration as Schedule D; and

WHEREAS, the undersigned Unit Owners wish to amend the By-Laws of the Condominium; and

WHEREAS, pursuant to Article X of such By-Laws, 66 2/3% of the Unit Owners in number and common interest agreed at said meeting to amend the By-Laws as hereinafter set forth.

NOW, THEREFORE, the undersigned Unit Owners hereby declare that the By-Laws (Schedule D to the Declaration of Condominium) of the Central Square Villas Condominium are amended by adding additional text to Article IX, Section 9.01, as follows:

ARTICLE IX - SELLING, MORTGAGING AND LEASING UNITS

9.01 Selling, Mortgaging and Leasing Units.

Only Unit Owners who hold title to a Unit and are currently renting their Unit as of the recording of this Amendment will have the right to continue leasing their Unit, until the lease term expires, and then the Unit can no longer be leased. Owners that are not leasing their Unit at the time of this Amendment being recorded or once any Unit is conveyed to a subsequent Owner, the Unit may no longer be leased and must be owner occupied.

An Owner who has deeded their Unit to another party for estate planning purposes and continues to reside in the Unit will still be considered an Owner for the purpose of that Unit being considered "owner occupied." However, once title to a Unit is transferred to a new Owner after the recording date of this Amendment, the right to lease that Unit ends regardless of whether the prior Owner remains in residence.
